**Directions to Timber Ridge**

Exit 36 off the Maine Turnpike. Immediately take Exit 1. At the stop light, take a left onto Industrial Park Road. Follow down to the next light at the intersection of Rt. 112 and turn right onto Rt. 112. Go 6 miles and take a left onto Route 117, then take a left onto Simpson Road for 2.5 miles to Timber Ridge on the left. The address is 221 Simpson Rd. Saco, ME 04072.

**Where to Meet: TBD**

Depending on the number of entries, we may meet at Timber Ridge Farm for tracking or we may meet for breakfast on Saturday. **Directions to Tory Hill Café'**

Take Exit 36 off the Maine Turnpike (1-95) then take exit 1 to Industrial Park Rd. Take a left on the Industrial Park Road to RT 112. Take a right on to Rt. 112 and go to the intersection of Rt. 202 & 112 (approximately 6 miles) At that intersection, take a left, go approximately ¼ – ½ mile and take a left onto Pinkham Drive. The Café is on the right. The Café's phone is 207-929-5665
